The Comet Platform is operated by the GFA Limited and contains data and statistics in relation to all official football matches played in Gibraltar.

We are registered in Gibraltar under company registration number 110334 whose registered address is 7.01b World Trade Center Gibraltar.

By using the Comet Platform you accept these terms
