GFA FUTSAL LEAGUE RULES 2023-2024



SCOPE OF FUTSAL LEAGUE RULES

1. General Provisions

1.1 The GFA Futsal Leagues are made up of two separate divisions comprising of:

- (a) the GFA Futsal League (Premier Division),
- (b) the GFA Futsal League (First Division),

each of which consists of the Clubs and/or Teams listed in Schedule 11 of this GFA Handbook.

1.2 The organisation, management and operations of the GFA Futsal Leagues shall be the responsibility of the GFA.

1.3 Clubs (inclusive of all Players, Club Officials and Club Personnel) must comply and shall be bound by these Futsal League Rules.

1.4 The GFA shall have the power and authority to amend these Futsal League Rules from time to time.

1.5 The GFA shall exclusively retain the power to approve and implement such ancillary rules and policies, together with clarifying matters of ambiguity concerning the GFA Futsal Leagues or any other additional aspects which may affect the GFA Futsal Leagues.

1.6 The GFA shall exclusively retain all entitlement and authority to use, assign, sell or otherwise take advantage of all marketing and commercial rights associated with the GFA Futsal Leagues, inclusive of pursuing such commercial opportunities and/or agreements and partnerships which may be in the best interests of the GFA Futsal Leagues.

2. Laws of the Game

2.1 Unless otherwise provided for in these GFA Futsal League Rules, all Matches in the GFA Futsal Leagues will be played in conformity with the Futsal Laws of the Game promulgated by FIFA as the same may be amended from time to time.

2.2 Matches in the GFA Futsal League (First Division) will be comprised of two halves of 25 running minutes, with only stoppages permitted by means of a Time-Out (as defined in the Futsal Laws of the Game) and during the final three (3) minutes of a match.

3. Club Participation in the GFA Futsal Leagues

- 3.1 A Club shall only be eligible to participate in either the GFA Futsal League (Premier Division) and the GFA Futsal League (First Division) if it is duly registered with the GFA.
- 3.2 A Club shall only be eligible to register one Team to participate in each of the GFA Futsal League (Premier Division) and the GFA Futsal League (First Division), and comply at all times with the squad quotas set out in Schedule 12.
- 3.3 No new Clubs and/or Teams will be registered in either of the GFA Futsal Leagues until such time as the GFA is able to confirm that all existing Clubs and/or Teams have been re-registered, such that it is able to advise whether new Clubs and/or Teams will be invited to register to participate accordingly.
- 3.4 A Club and/or Team must register its Players in accordance with rule 4 below.
- 3.5 A Club may only acquire and transfer Players in accordance with the Status and Transfer Regulations contained in this GFA Handbook.
- 3.6 A registration fee of GBP 400 shall apply to all Clubs.

4. Player Registration for the GFA Futsal Leagues

- 4.1 Players must be registered in accordance with all applicable GFA Statutes and the Status and Transfer Regulations before being eligible to be registered to form part of a Team registered by a Club to compete in either of the GFA Futsal Leagues.
- 4.2 A Player shall only be eligible to register and apply to play in either of the GFA Futsal Leagues if he is the age of sixteen years or over. Players under the age of eighteen must provide their Club and the GFA with written parental and/or guardian consent in order to play.
- 4.3 A registration fee of GBP 50.00 shall apply to all Players.
- 4.4 During any point in any given futsal season, the minimum number of Players that may be registered in a Team is 10, and the maximum number of Players shall be 16 (save for the exception pertaining to University Players per rule 4.14 of these Futsal Rules.)
- 4.5 If at any time during the futsal season, a Club does not have the prescribed minimum number of Players registered, the Club shall be automatically removed from the GFA Futsal League it competes in, and the GFA shall notify the Club of this in writing.
- 4.6 A Team may only have a maximum of 8 Non-Home-Grown Players registered in its squad.

- 4.7 The maximum number of Players eligible to represent a team in a match shall be 14. This maximum may only be achieved if a Team has selected a minimum of 8 Home-Grown Players for the match. If a team has fewer than 8 Home-Grown Players registered, then the maximum number of Players eligible to represent a team in a match is reduced accordingly. Match Officials shall check and ensure that this requirement is adhered to by both Teams prior to commencing any Match.
- 4.8 The possible combinations of the types of Players that enable a Club to comply with the foregoing requirements are set out in Schedule 13.
- 4.9 A Futsal League Match shall be played by two Teams, consisting of a maximum of 5 Players on each Team.
- 4.10 A Futsal League Match may not start if a Team is comprised of less than 3 Players. In such a case, the Futsal League Match will be abandoned and the Team with less than 3 Players will be deemed to forfeit the Futsal League Match.
- 4.11 The minimum number of Players on a team sheet on a match day shall be 6 Players. If a Team has less than 6 Players on a match day, the Futsal League Match will be played, but the applicable Team will receive a Warning.
- 4.12 Upon receipt of three Warnings, the Team will receive a fine. Further, a Team found to be unable to complete a Futsal League Match due to having insufficient number of Players shall receive a fine in accordance with the Disciplinary Regulations.
- 4.13 All Teams will at all times field a minimum of 2 Home-Grown Players on the court for the duration of a Futsal League Match.
- 4.14 For the avoidance of doubt, University Players will not count towards the squad quotas listed in Schedule 12. Teams in the GFA Futsal League (Premier Division) and the GFA Futsal League (First Division) may only have a maximum of three (3) University Players in their Team. For the avoidance of doubt, this rule is only applicable if the University Player is enrolled at a University outside of Gibraltar. If the University Player permanently returns to Gibraltar, he will automatically be added to the Team's squad quota (subject always to inter clearance procedures).
- 4.15 For the avoidance of doubt, a Player registered with a team cannot be concurrently registered as a Club Manager, Coach Club Official of a different team.

5. Transfers & Registration Window

- 5.1 There will be two transfer windows for each of the GFA Futsal Leagues, namely:
- (a) the Summer Transfer Window; and
 - (b) the Winter Transfer Window.

- 5.2 During each Transfer Window, Clubs shall be permitted to register and transfer Players in accordance with all applicable GFA Statutes, including the Status and Transfer Regulations.
- 5.3 Players may be registered with a maximum of two Clubs during one futsal season. During this period, a Player is only eligible to play in Futsal League Matches for a maximum of two Clubs in one futsal season.
- 5.4 For the avoidance of doubt, a transfer fee of GBP 50 will apply to all transfer of Players.

6. GFA Communication on Particulars of GFA Futsal Leagues

- 6.1 The following particulars and details concerning each of the GFA Futsal Leagues shall be confirmed and communicated by the GFA to Clubs by no later than 30 days prior to the commencement of the relevant futsal season, namely:
- (a) commencement date of each of the GFA Futsal Leagues;
 - (b) number of teams registered to participate in each of the GFA Futsal Leagues;
 - (c) number of rounds to be played in each of the GFA Futsal Leagues;
 - (d) schedule of fixtures for the forthcoming futsal season for each of the GFA Futsal Leagues;
 - (e) number of teams which would be eligible for promotion from the GFA Futsal League (First Division) to the GFA Futsal League (Premier Division); and
 - (f) the GFA Futsal League (Premier Division) and the GFA Futsal League (First Division) shall commence on 3 September 2022 and shall conclude by no later than June, 2023.

7. GFA Futsal League Champions

- 7.1 The winner of the GFA Futsal Premier League shall be the Team that wins the GFA Futsal Premier Final Four Playoffs.
- 7.2 The Team which ranks first in the GFA Futsal League (Premier Division) table at the end of two rounds played shall be presented with a commemorative shield and shall receive prize money in the amount of GBP 1000 but shall not be considered the winner of the GFA Futsal Premier League.
- 7.3 The Team which ranks first in the GFA Futsal League (First Division) table at the end of two rounds played of the GFA Futsal League (First Division) shall be crowned the GFA Futsal League (First Division) Champions, and as such, shall receive a trophy from the GFA.
- 7.4 Trophies and shields presented by the GFA must be returned no later than three weeks prior to the final match of the relevant Futsal league. Any damage sustained by the trophies or shields will need to be paid and remedied by the Team responsible for

causing said damage. Any failure or omission to remedy any damage to said trophies will result in the GFA automatically deducting any amounts payable for the damage from any funds payable to the applicable Team by the GFA.

- 7.5 The team which ranks first in the GFA Futsal League (Premier Division) table and the GFA Futsal League (First Division) Champions shall receive commemorative medals. The commemorative medals shall be presented to the Team, the Club Manager and to any Players and Club Officials the Club think fit, subject always to all Players who have played a minimum of five Futsal League Matches being given first priority in order to receive a commemorative medal.

8. **Promotion and Relegation**

- 8.1 In regard to the GFA Futsal League (Premier Division), the Team which is ranked last at the end of two rounds played in the GFA Futsal League (Premier Division) shall be automatically relegated to the GFA League (First Division) for the following futsal season.

- 8.2 In regard to the GFA Futsal League (First Division), the GFA Futsal League Champions shall be automatically promoted to the GFA League (Premier Division) for the following futsal season.

- 8.3 The Team which is ranked second at the end of two rounds played in the GFA Futsal League (First Division) shall play an additional playoff Match against the penultimate ranked Team at the end of two rounds played in the GFA Futsal League (Premier Division), in order to determine which Team will remain, or be relegated and/or promoted to a different GFA Futsal League division. The winner of this playoff Match shall compete in the GFA Futsal League (Premier Division) and the loser shall compete in the GFA Futsal League (First Division) for the following futsal season.

9. **Format and Structure of GFA Futsal Leagues and Final Four Playoffs**

- 9.1 Each of the GFA Futsal Leagues shall consist of 2 rounds, where all Teams pertaining to each respective GFA Futsal League shall play each other twice.

- 9.2 Following the completion of two rounds of Matches in each of the GFA Futsal Leagues, the Teams which are ranked first to fourth in the GFA Futsal League (Premier Division) shall play in the GFA Futsal Premier Final Four Playoffs.

- 9.3 The Team which is ranked first shall play a best of three games semi-final series against the Team which is ranked fourth, and the Team which is ranked second shall play a best of three games semi-final series against the Team which is ranked third. The Teams which win their respective semi-final series shall qualify for the GFA Futsal Premier Final Four Playoff finals. A winner must be determined in each of the Matches of the GFA Futsal Premier Final Four Playoffs. In the case of a Match concluding in a tie, the Match will be determined by way of a penalty shoot-out.

9.4 The Teams competing in the finals of the GFA Futsal Premier Final Four Playoffs shall play a best of three games final series. A winner must be determined in each of the Matches of the finals of the GFA Futsal Premier Final Four Playoffs. In the case of a Match concluding in a tie, the Match will be determined by way of a penalty shoot-out. The winners shall be crowned the GFA Futsal Premier Final Four Playoff Champions, and shall:

- (a) be eligible to compete and participate in the UEFA Futsal Cup for the following futsal season as the winners of the top domestic futsal league (and also receive the corresponding UEFA remuneration and corresponding GFA assistance in relation to the same);
- (b) receive prize money in the amount of GBP 4,000.00.

10. **The GFA Futsal Rock Cup**

10.1 All GFA Futsal League Clubs (Premier and First Division) are eligible for this competition, they will be knock out rounds, teams being drawn and played according to FIFA FUTSAL regulations. In each Rock cup game a winner must be determined in the event of a draw, at least 5 penalty kicks will determine the winner of the game.

10.2 The winners shall be crowned the GFA Futsal Rock Cup Champions, and shall:

- (a) shall receive a trophy from the GFA, but which shall be returned in the same order and condition as received by no later than three weeks prior to the Rock Cup Final Match of the following futsal season.
- (b) be eligible to compete and participate in the GFA Luisito Bonavia Trophy for the following futsal season.

10.3 For the avoidance of doubt, a Player shall not play for more than one Club and/or Team in the GFA Futsal Rock Cup in the same season.

11. **The GFA Futsal Luisito Bonavia Trophy**

11.1 The GFA Futsal League Premier Final Four Playoff Champions and the GFA Futsal Rock Cup Champions shall be eligible to compete for the GFA Futsal Luisito Bonavia Trophy, which shall be the inaugural Match of the following futsal season.

11.2 To the extent that the GFA Futsal League Premier Final four Playoff Champions are the same Team as the GFA Futsal Rock Up Champions, the runners-up of the GFA Futsal Rock Cup will be entitled to compete against the GFA Futsal League Premier Final Four Playoff Champions for the GFA Futsal Luisito Bonavia Trophy.

12. **Scoring System and League Table**

12.1 The winner of a Futsal League Match shall be awarded three points.

- 12.2 To the extent that a Futsal League Match concludes in a draw, each Team shall be awarded one point.
- 12.3 No points shall be awarded to the losing Team of a Futsal League Match.
- 12.4 In the event of a Team being expelled from participating in either of the GFA Futsal League during the active futsal season, all points acquired and goals scored and/or conceded by the other Team against the expelled Team will be removed.
- 12.5 The results of Futsal League Matches for each of the GFA Futsal Leagues shall be recorded by the GFA in separate league tables comprising in the following information in respect of each Team, namely:
- (a) in the case of the GFA Futsal League (Premier Division):
 - (i) the number of Futsal Premier League Matches played;
 - (ii) the number of Futsal Premier League Matches won, drawn and/or lost as a home team;
 - (iii) the number of Futsal Premier League Matches won, drawn and/or lost as an away team;
 - (iv) the aggregate number of goals scored and conceded by each Team in each Futsal Premier League Match; and
 - (v) the number of points earned by each Team during the GFA Futsal League (Premier Division).
 - (b) in the case of the GFA Futsal League (First Division):
 - (i) the number of Futsal First Division League Matches played;
 - (ii) the number of Futsal First Division League Matches, drawn and/or lost as a home team;
 - (iii) the number of Futsal First Division League Matches won, drawn and/or lost as an away team;
 - (iv) the aggregate number of goals scored and conceded by each Team in each Futsal First Division League Match; and
 - (v) the number of points earned by each Team during the GFA Futsal League (First Division).
- 12.6 The rankings of Teams in each of the GFA Futsal League tables shall be determined by the aggregate number of points awarded during the course of each of the GFA League (Premier Division) and the GFA League (First Division), with the Teams having tallied the highest number of points being ranked first, and the Teams having tallied the lowest number of points being ranked last.
- 12.7 If any two or more Teams from the same GFA Futsal League have accumulated an equal number of points, the requisite tie-breaker will be decided by determining which of the Teams had the best head-to-head goal difference. This means that their rankings

will be determined by the aggregate amount of goals scored and conceded by each Team in all applicable Futsal League Matches played against each other. The highest ranking Team shall be the Team with the highest amount of points.

- 12.8 If any two or more Teams have accumulated an equal number of points and have the same head-to-head goal difference, the requisite tie-breaker will be decided by both Teams competing in an additional playoff Match to determine (as the case may be and apply to either GFA Futsal League), the GFA Futsal League (Premier Division) Champions and/or the GFA Futsal League (First Division) Champions. In the case of the Match concluding in a tie, the Match winner will be determined by way of a penalty shoot-out. For the avoidance of doubt, this shall only be applicable when determining the rankings in order to decide on the GFA Futsal League (Premier Division) Champions, or rankings with respect to Teams in either GFA Futsal League which may be eligible for promotion or relegation.

13. Force Majeure

- 13.1 In the event that either and/or both of the GFA Futsal Leagues cannot be completed and must be concluded prematurely, it shall be declared null and void unless a Team has already mathematically won either competition.

14. Inability to Field a Team for a League Match

- 14.1 In the event that a Club is unable to field a team for a Futsal League Match, the following procedure will be adhered to:
- (a) The Club must notify the GFA in writing via electronic mail within 72 hours of the applicable Futsal League Match explaining the reasons for its inability to field a team and formally requesting a postponement (to be accompanied with such applicable documentary evidence).
 - (b) The GFA will, in its sole discretion, proceed to decide whether or not there are exceptional circumstances present which warrant rescheduling of the Futsal League Match in question and communicate the decision to the Club by electronic mail within 24 hours of receiving the Club's initial request.
- 14.2 In the event that the GFA determines that the applicable Futsal League Match should be postponed, the GFA will provide a new date for the postponed Futsal League Match and shall inform the relevant Clubs within 24 hours of such decision being taken.
- 14.3 In the event that the GFA determines that the applicable Futsal League Match should not be postponed and the Club remains unable to field a team, 3 points will be awarded to the opposing Club in the Futsal League Match in question. Disciplinary Sanctions may follow thereafter to the Club that does not field a team in accordance with the Disciplinary Regulations.
- 14.4 For the avoidance of doubt, the foregoing provisions of rule 14 shall not be applicable to a Club's inability to field a team as a result of a Covid-19 related issue. Such scenario

shall be dealt with in accordance with the GFA Covid-19 Protocol as amended from time to time.

15. Team Sheets

15.1 Prior to every Futsal League Match played, each competing Club shall accurately insert and complete the details of their Team for that Futsal League Match on the COMET system. The particulars to be provided shall be uploaded onto the COMET system by no later than 1 hour prior to kick-off, and shall include:

- (a) 5 starting players (with corresponding shirt numbers);
- (b) a maximum of 9 substitutes (with corresponding shirt numbers); and
- (c) a maximum of 7 Club Officials who fulfil the following roles:
 - (i) the Club Manager (mandatory);
 - (ii) an assistant manager (mandatory);
 - (iii) physical trainer;
 - (iv) physiotherapist;
 - (v) doctor;
 - (vi) team delegate; and
 - (vii) applicable coaching staff.

15.2 For the avoidance of doubt, only the personnel listed in rule 15.1 above named on the team sheet are permitted in the Technical Area. A breach of this rule shall result in a fine in accordance with the Disciplinary Regulations.

15.3 Unless otherwise permitted by these Futsal League Rules, no changes will be allowed to team sheets uploaded on the COMET system within 1 hour of kick-off of the applicable Futsal League Match.

15.4 To the extent that there is an injury to one of the starting Players immediately prior to kick-off, a named substitute may replace the injured Player in the starting line-up only. This will be attended to by a Match Official. Said named substitute may not in turn also be replaced by an additional Player.

15.5 The GFA shall use its best endeavours to ensure that the information provided for COMET is correct, accurate and up to date at all times. In the event of any human error and/or data processing, Clubs are nevertheless reminded that it is the sole responsibility of each Club to keep a record of any active Cautions, Dismissals and other applicable Disciplinary Sanctions imposed on the Club (including the Team, Players, Club Officials and Club Personnel), and ensure that the necessary information provided in each team sheet is correct and accurate and that the listed Players and Club Officials are eligible to participate in accordance with the rules and regulation of this GFA Handbook and the GFA Statutes.

- 15.6 Match Officials will check each team sheet prior to each Futsal League Match.
- 15.7 A Team will be allowed to substitute up to 9 Players in a Futsal League Match. The number of total substitutions which may be made in a Futsal League Match shall be unlimited.
- 15.8 Team sheets must be accurate on Match days. Failure to comply with this will result in a warning for a first offence and a fine for further offences in accordance with the Disciplinary Regulations.

16. **Checking of Identity**

- 16.1 Players and Club Officials named in the team sheet are obliged to have with them the GFA identity card.
- 16.2 The GFA identity card of all persons listed on a team sheet may be inspected by a Match Official prior to kick-off.
- 16.3 In the event that a Player is not able to provide his GFA identity card, the Player will not be allowed to play or sit in the Technical Area unless said Player is able to provide another relevant official government form of identification. In the case of a Club Official, they will not be permitted to sit in the Technical Area.
- 16.4 The burden of proof as to the identity of a Player or Club Official participating in a Futsal League Match shall rest with the Player and/or Club Official whose identity is being questioned by a Match Official or the GFA.

17. **Match Ball Requirements**

- 17.1 The GFA will provide the Match balls to be used for each Futsal League Match.
- 17.2 On Match day, the Match Officials will provide up to three Match balls for any given Futsal League Match.
- 17.3 Club Officials from both Teams shall confirm the number of Match balls provided prior to kick-off, and shall ensure that these are returned to the Match Officials or relevant GFA Personnel at the end of the game.
- 17.4 In the event that a Match ball is lost and/or destroyed during a Futsal League Match, both Teams shall agree to evenly pay the costs associated with the replacement of the lost and/or destroyed Match ball within 7 days.
- 17.5 To the extent that the loss and/or destruction of a Match ball arises from a deliberate act by one Player, Team and/or Club, the Player, the Team and/or Club responsible for such an act will pay the cost in full. The GFA will in its sole discretion determine whether an act is to be construed as deliberate.

18. Match Officials

18.1 All Futsal League Matches will be administered and policed by Match Officials in accordance with the Futsal Laws of the Game and the GFA Referee Regulations as amended from time to time.

19. Advertising

19.1 Regulations on Advertising as set out in the Football League Rules shall apply to these Futsal League Rules.

20. Sponsor Designations

20.1 Regulations on Sponsorship Designations as set out in the Football League Rules shall apply to these Futsal Rules.

21. Player Identification and Strip

21.1 Before the commencement of each futsal season, each Club shall allocate a different shirt number to each Player of its Team, and allocate a shirt number to any Player joining the Club and Team during the course of the futsal season.

21.2 Save with prior written consent of the GFA, shirt numbers may only range between numbers 1 to 19. The shirt bearing the number 1 must be worn by a goalkeeper only.

21.3 Following a Player's departure from a Club, said shirt number shall be surrendered and re-allocated to a new Player.

21.4 When playing in Futsal League Matches, each Player shall wear a shirt on the back of which shall be prominently displayed his shirt number and (if so desired by the Club or the Player), above said number, the Player's surname or such other name as may be approved in writing by the GFA.

21.5 The Player's shirt number shall also appear on front on his shirt and/or shorts.

21.6 The colour and design of the Club's shirt, shorts and socks shall be submitted by the Club to the GFA by no later than 30 days prior to the commencement of the futsal season. This shall apply for Club's home and away kits.

21.7 The colour and design of the shirt, shorts and sock worn by goalkeepers when playing in Futsal League Matches shall be such as to distinguish him from the other Players and Match Officials.

21.8 The Team deemed to be playing at home (the Team listed first on the latest available published fixtures) must wear its designated home kit, and the team deemed to be playing away (the Team listed second on the latest available published fixtures) must wear its designated away kit.

- 21.9 Where the kits of two competing Teams are similar, the Team deemed to be playing as the away Team (the Team listed second on the latest available published fixtures) must change its kit unless alternative arrangements are mutually agreed by the two competing Teams in conjunction with the consent of the Match Officials.
- 21.10 The captain of each Team appearing in a League Match shall wear a captain's armband indicating his status as such.

22. Disputes, Complaints & Special Requests

- 22.1 Any dispute or complaint by a Team and/or Club regarding another Team and/or Club must be officially reported to the GFA within 48 hours from the date of such facts or events giving rise to said dispute or complaint, and shall be dealt with in accordance with the Disciplinary Regulations in this GFA Handbook.
- 22.2 Any dispute or complaint received after 48 hours from the date of such facts or events giving rise to said dispute or complaint shall not be valid or accepted by the GFA.
- 22.3 With regards to requests for a one minute silence prior to a Futsal League Match, this shall only be permitted under the following circumstances:
- (a) a national or international tragic event;
 - (b) a national event;
 - (c) a demonstration of respect for the death of individuals who have contributed to the game of football in Gibraltar or internationally; or
 - (d) the death of a Player or Club Official.

23. Ancillary Intermediate League Provisions: Cautions, Dismissals and Suspensions

- 23.1 The following provisions of this rule 23 will apply to Players, Club Managers, Club Officials and Clubs registered in the Futsal League.
- 23.2 The Disciplinary Regulations will apply to the GFA Futsal Premier Final Four Playoffs except that prior to the commencement of the GFA Futsal Premier Final Four Playoffs, the aggregate amount of a Player's accumulated Cautions and Dismissals shall be reset to zero. However, any period of suspension which remain outstanding at the end of a season must be served at the commencement of the GFA Futsal Premier Final Four Playoffs.
- 23.3 The following rule will apply for the rest of the GFA Futsal Premier Final Four Playoffs, if a Player or Club Official accumulates two cautions ("initial two cautions") in the GFA Futsal Premier Final Four Playoffs said Player or Club Official will be automatically suspended for a period of one Match which will be served in the Club's next immediate Match in the said competition. If following the "initial two cautions" the Player or Club Official accumulates two further cautions (i.e. four cautions in total) in the GFA Futsal

Premier Final Four Playoffs, the said Player or Club Official will be automatically suspended for a period of one Match which will be served in the Club's next immediate Match in the said competition.

- 23.4 For the avoidance of doubt, any outstanding suspensions following the conclusion of the GFA Futsal Premier Final Four Playoffs must be served at the commencement of the following Futsal League season.

24. **Breach of Futsal League Rules**

- 24.1 Any breach of these Futsal League Rules will be dealt with by the GFA's Disciplinary Control Unit in accordance with the Disciplinary Regulations in this GFA Handbook.
- 24.2 The GFA may also take any action necessary to address any breaches which may not be adequately addressed under the Disciplinary Regulations providing that such actions are reasonable and proportionate.
