ROLE PURPOSE:

Your primary role will be to draft, develop and maintain the Gibraltar FA disciplinary and regulatory processes. This ranges from supervising, coordinating and appearing before disciplinary hearings established by the Gibraltar FA, to drafting rulings made by the respective judicial bodies.

On a daily basis, you will be interpreting and applying a range of competition and disciplinary regulations as issued by Gibraltar FA, UEFA and FIFA. You will also provide legal and administrative support to the Disciplinary Control Unit where necessary. This role has a certain level of autonomy and responsibility, under the supervision of the Legal Director.

As such, you will work closely with the General Secretary and external legal advisors from time to time, in providing advice to the Gibraltar FA's business units, including compliance, corporate governance, employment, litigation, intellectual property, insurance, privacy, procurement, venue hire and general commercial matters.

You will liaise with our stakeholders on regulatory, governance, disciplinary and legal matters, and therefore have a crucial role in developing and maintaining corporate governance procedures as well as internal use of personal data.
